Treasurer's Report 2011 - 2012

We are very thankful for the organizations and individuals that choose to support the mission of the Thompson through grants and by contributing to the Annual Appeal and fundraising events. In these difficult economic times, with increasing demand for services, we are unable to break even and must continue to depend on our endowment for budgeted shortfalls. In fiscal year 2012, steps were taken to bring expenses more in line with income which resulted in a decrease in expenses. This, combined with an increased push for new grants and our most successful ever Valentine Auction and Holiday Bazaar events, improved our bottom line. The Board and staff are committed to controlling expenses and sustaining fundraising revenue. In addition, we look to growing our endowment so that over the long term we will have sufficient funds to meet our shortfalls for operating needs and capital projects.
